### DESCRIPTION

Production is strictly controlled and follows an extensive set of instructions established for reproducibility. Α homogeneous film of metal alloy is deposited on a high grade ceramic substrate and conditioned to achieve the desired temperature coefficient. A special laser is used to achieve the target value by smoothly cutting a meander groove in the resistive layer without damaging the ceramics. A further conditioning is applied in order to stabilize the trimming result. The resistor elements are covered by a protective coating designed for electrical, mechanical and climatic protection. The result of the determined production is verified by an extensive testing procedure on 100 % of the individual chip resistors. This includes pulse load screening for the elimination of products with a potential risk of early life failures according to EN 140401-801, 2.1.2.2. Only accepted products are laid directly into the tape in accordance with EN 60286-3.

### ASSEMBLY

The resistors are suitable for processing on automatic SMD assembly systems. They are suitable for automatic soldering using wave, reflow or vapour phase as shown in IEC 61760-1. The encapsulation is resistant to all cleaning solvents commonly used in the electronics industry, including alcohols, esters and aqueous solutions. The suitability of conformal coatings, if applied, shall be qualified by appropriate means to ensure the long-term stability of the whole system. Solderability is specified for 2 years after production or re-qualification. The permitted storage time is 20 years.
