PET and PEN film from MYLAR, LX

Dear Distribution Partner,

the manufacturer MYLAR is discontinuing the production of PET and PEN film in mid-2025.

From the WIMA series

SMD PET / SMD PEN / MKS 02 / MKS 2 / MKS 4

individual articles are affected according to the attached overview.

You will also receive an updated list of your order history 2024/2025 with affected articles.

Intensive discussions are already underway with potential film suppliers to replace the obsolete PET film thicknesses, but a short-term solution cannot be expected.

Due to the uncertain supply situation, we strongly recommend that our customers order the required quantities for the next 1 to 2 years, or the entire future project requirements, now and thus secure their production.

To ensure that WIMA can make the last buy from MYLAR on time, the last possible order date for our distribution partners is

March 12, 2025

Please note the following points:

- 1. Existing orders confirmed by WIMA are expected to be delivered on time.
- 2. An official WIMA order confirmation for new orders will be issued when delivery confirmations have been received from MYLAR (end of March 2025 or later).

- 3. Delivery dates confirmed by WIMA must be accepted; we will try to meet your delivery date requests.
- 4. Even if the order deadline is met, WIMA is not obliged to deliver subject to MYLAR's ability to deliver.
- 5. Cancellation and postponement requests for orders placed as of now must be approved by WIMA on a case-by-case basis. Basically, NCNR applies.

Due to the last-buy date set by MYLAR at very short notice, we ask you to treat this matter with the highest priority.

With regard to PEN film there is no alternative, the WIMA SMD PEN series will be discontinued without replacement and a PCN will follow. We recommend checking whether SMD PPS can be considered as a replacement in the customer applications.
