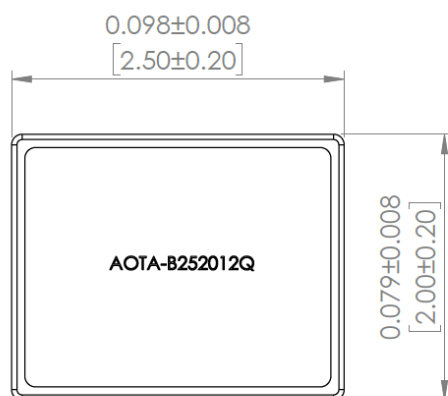

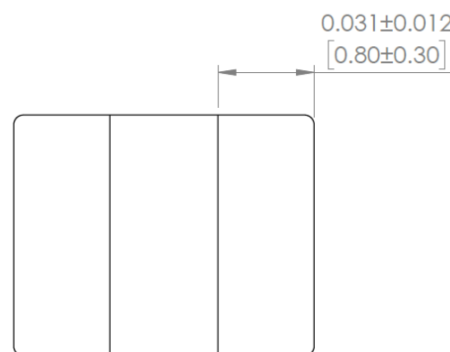

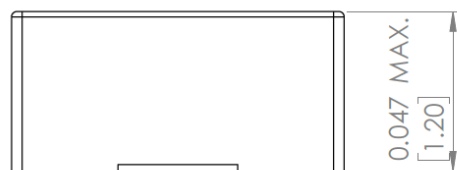

TOP VIEW

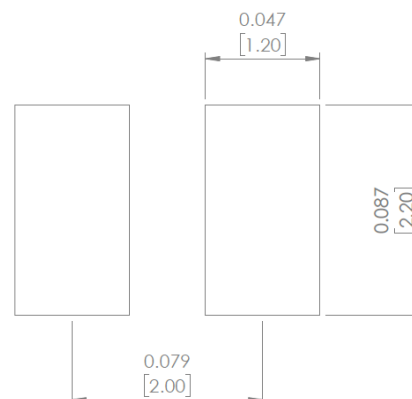


BOTTOM VIEW

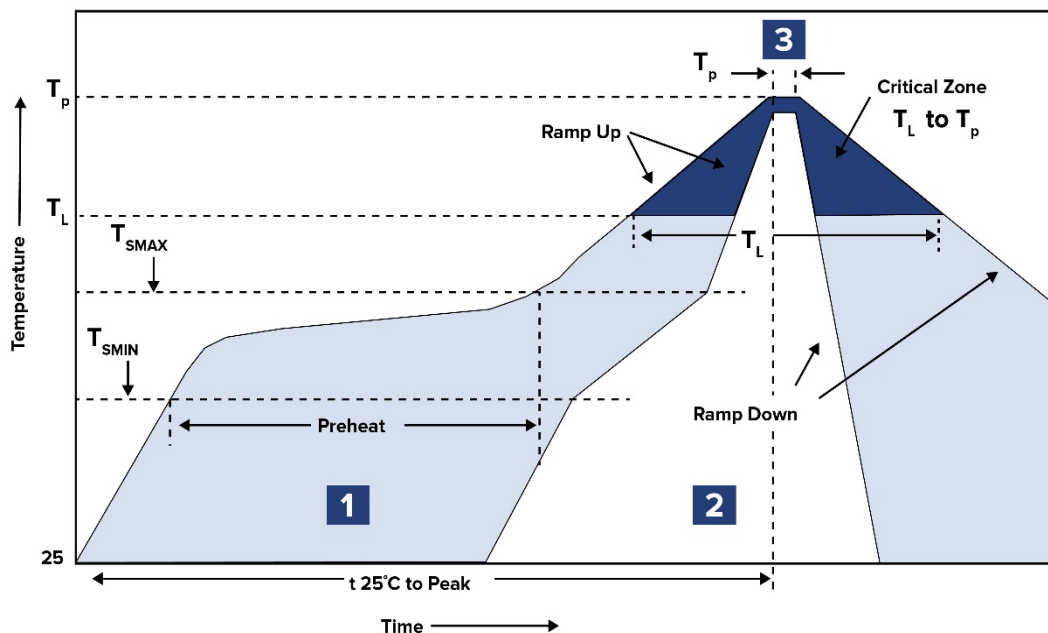

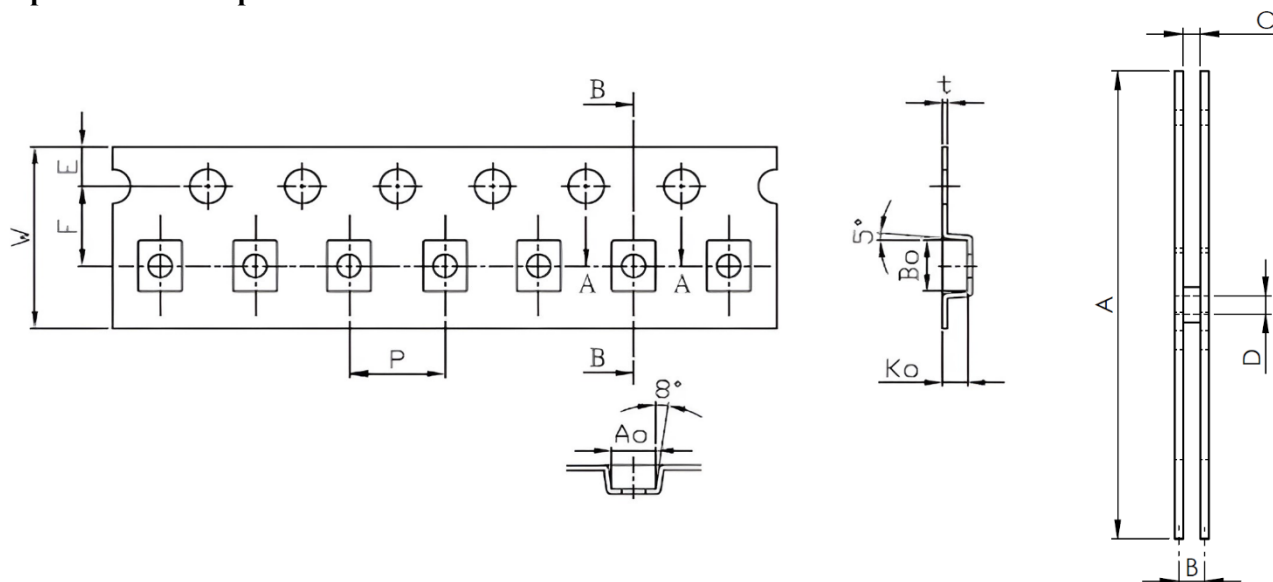
