





Fig.2 Typical Output Characteristics






Fig.3 DC Current Gain




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. Emitter Current



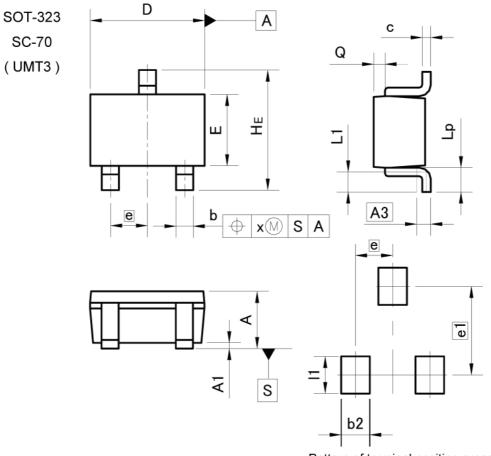
