






Fig.1 Ground Emitter Propagation Characteristics

Ta= 125°C






Fig.2 Typical Output Characteristics








EMITTER CURRENT : I_E[A]



Fig.10 Safe Operating Area




COLLECTOR TO EMITTER VOLTAGE : V_{CE} [V]
