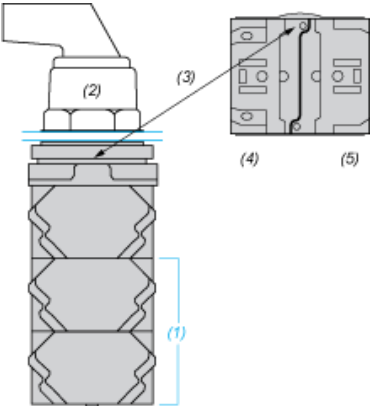

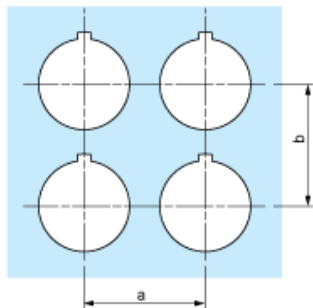
Top and Rear views

Panel Cut-Out

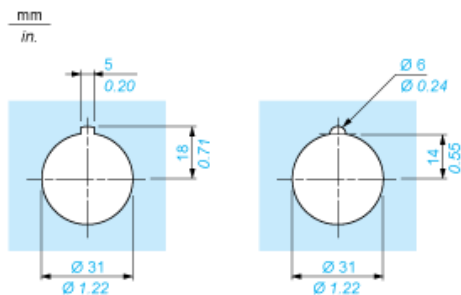
