### Typical Impedance Characteristics:

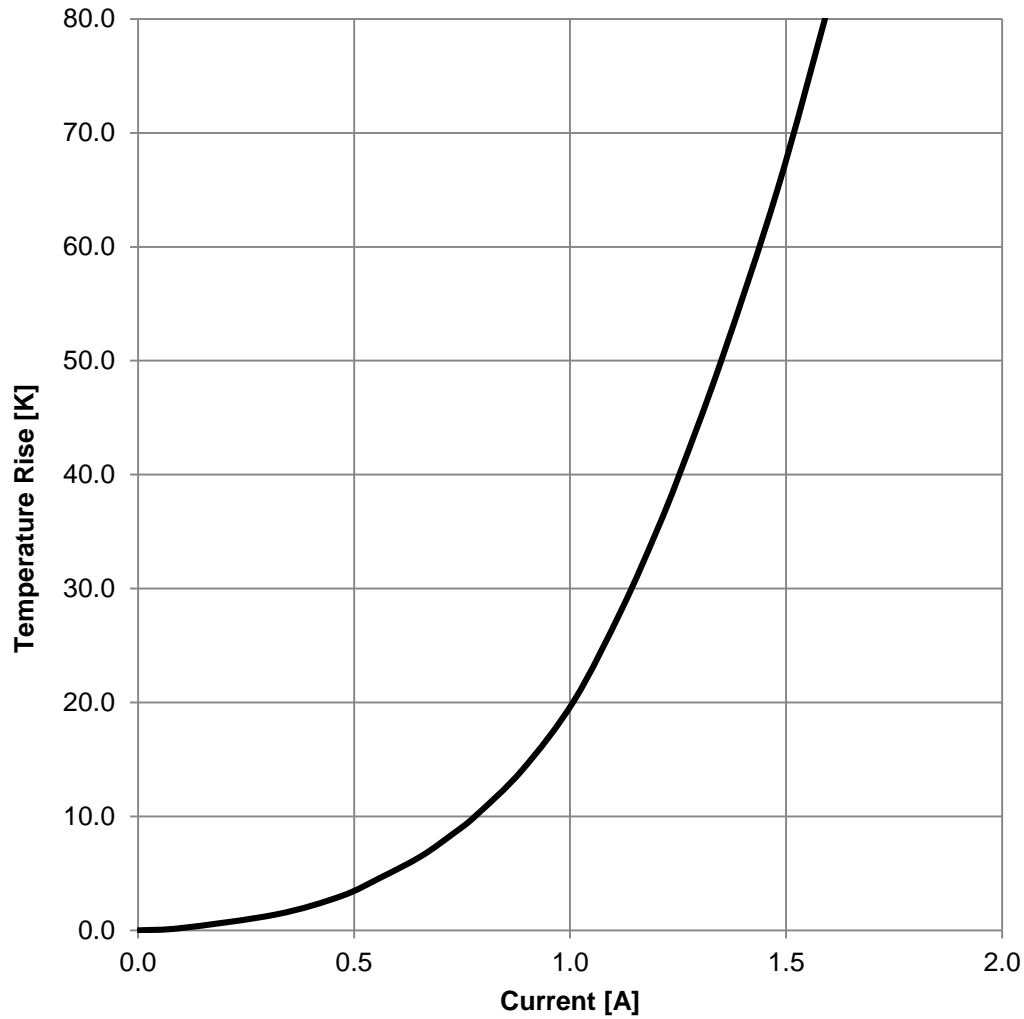

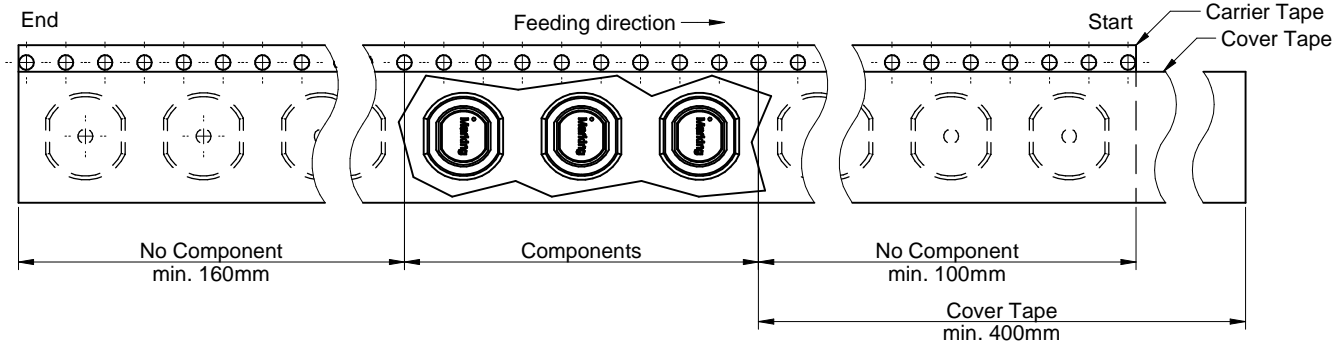
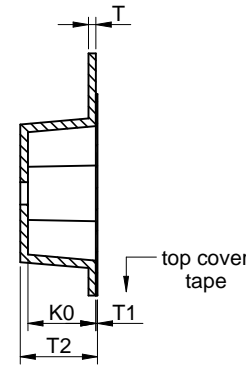
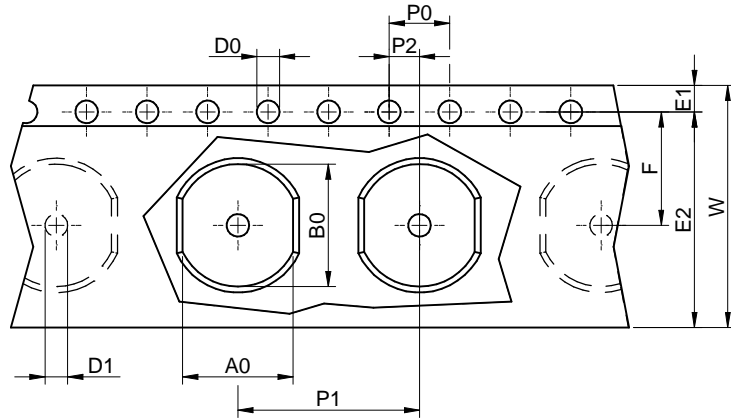
### Typical Temperature Rise vs. Current Characteristics:

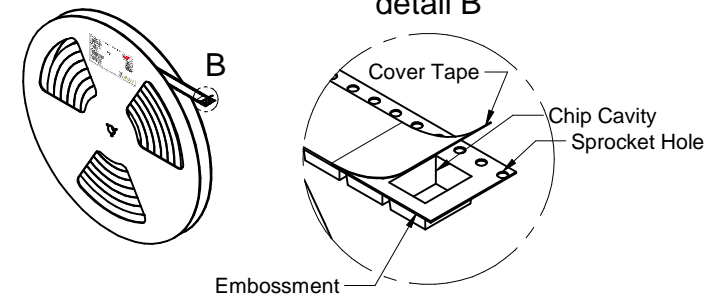
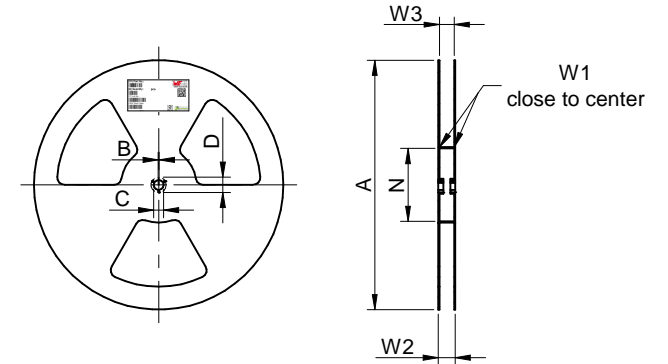

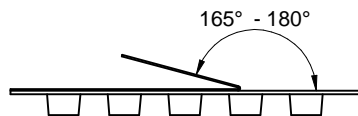

#### Soldering



#### Packaging:
