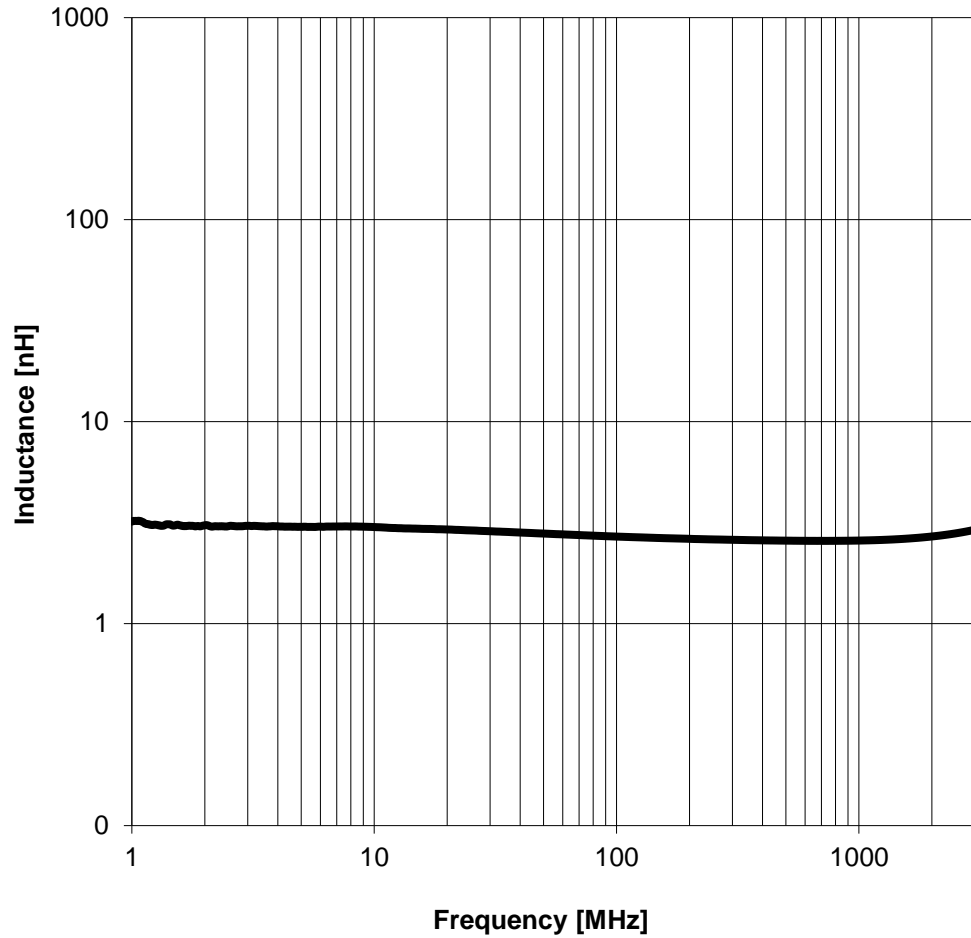

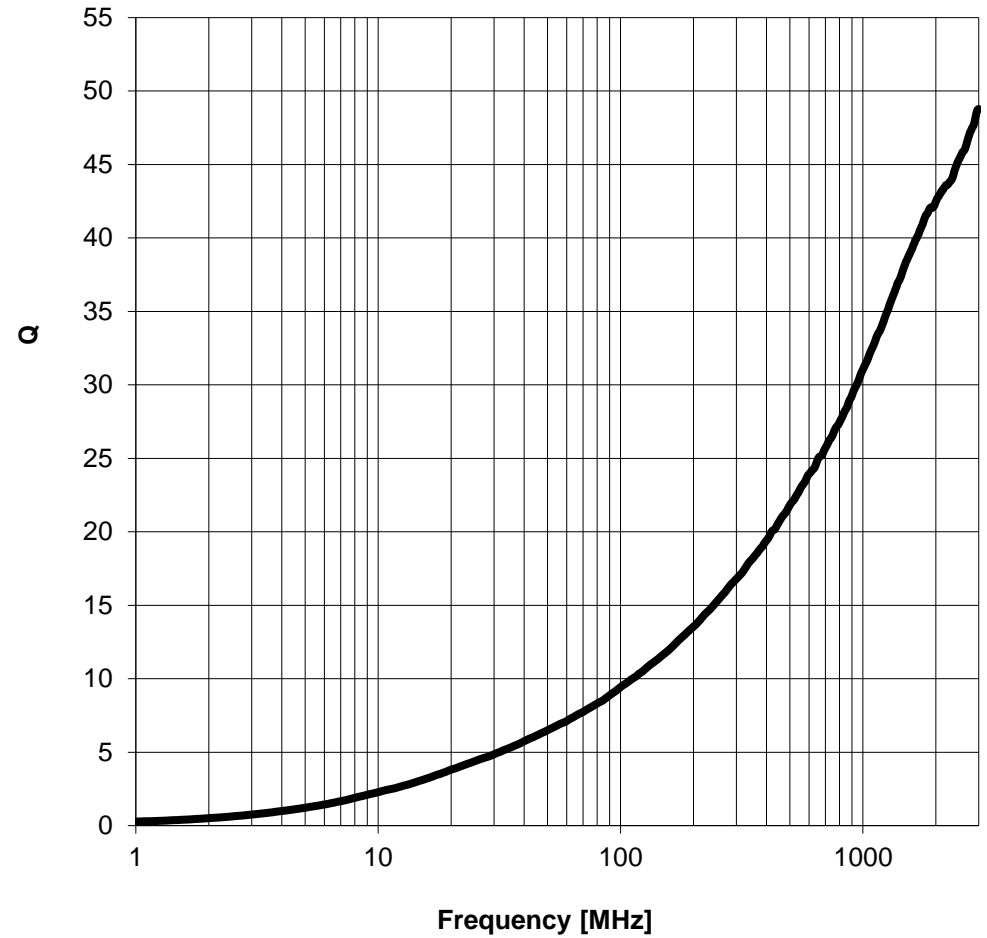



Storage Conditions:


