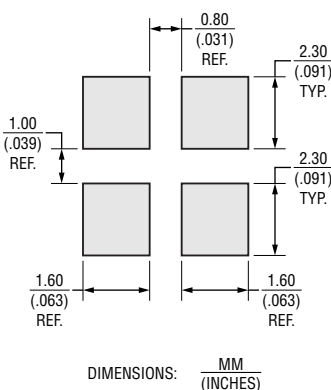

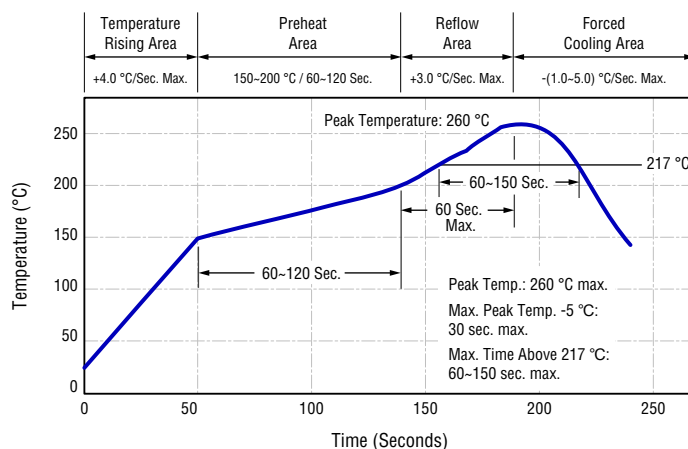

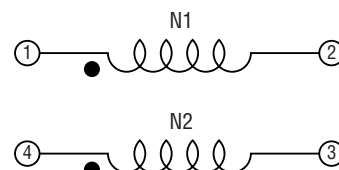

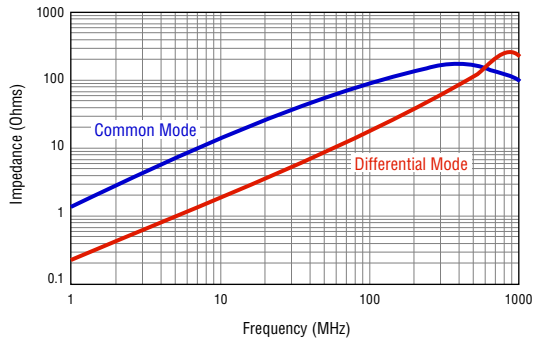

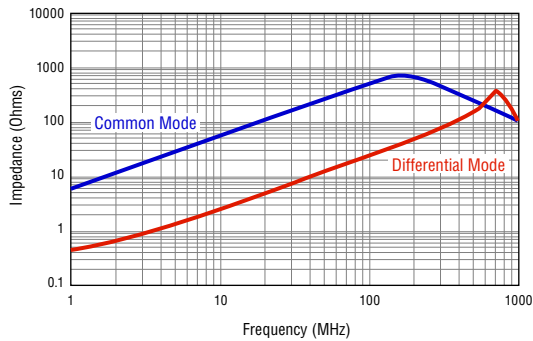

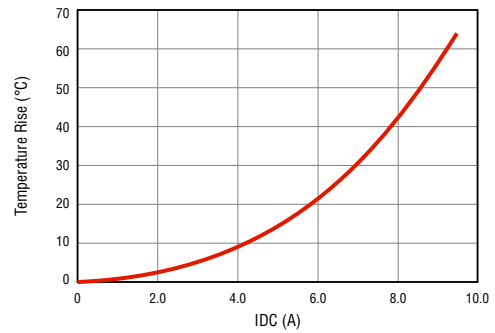

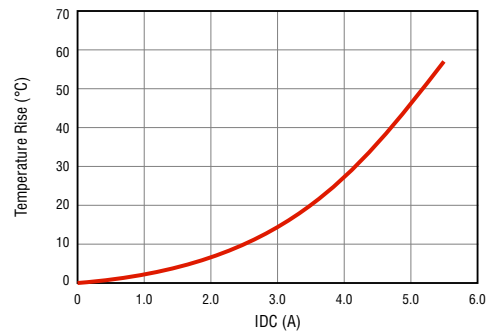


Temperature Rise Plots

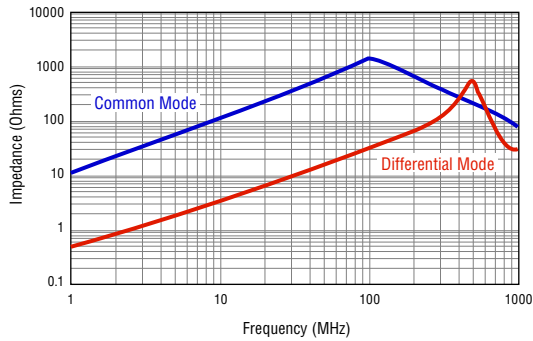

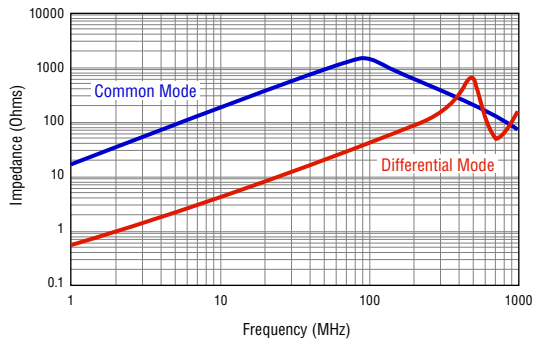

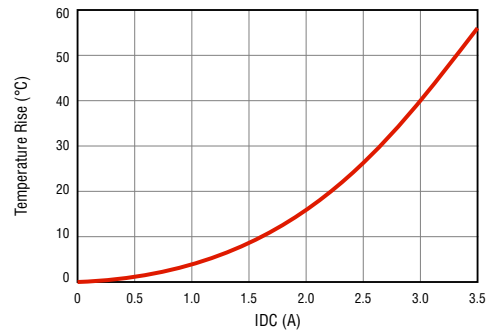

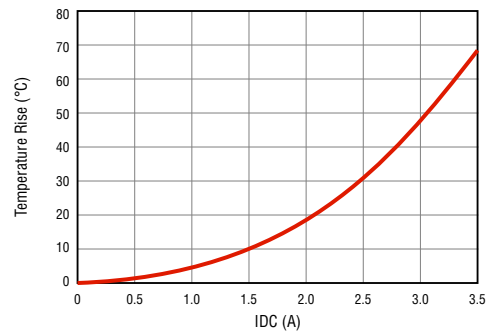


Temperature Rise Plots

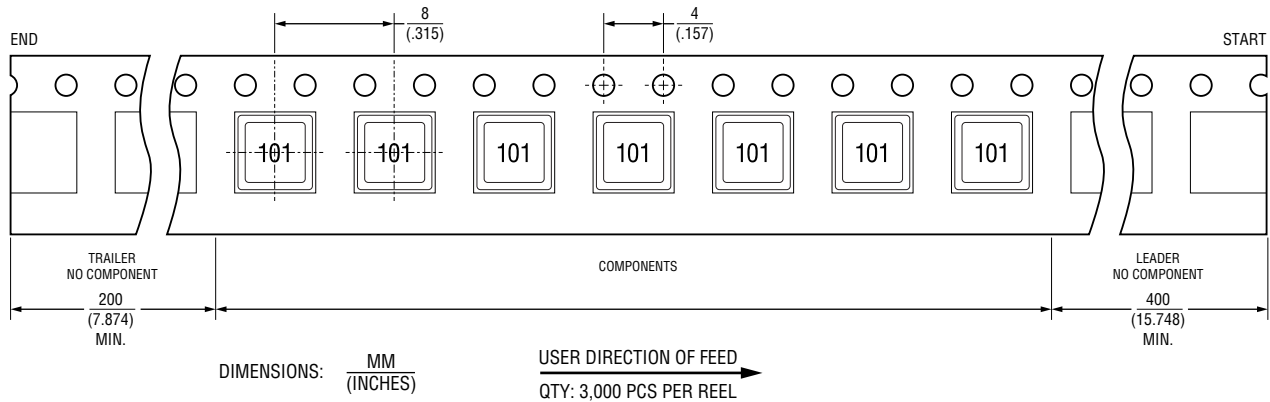
