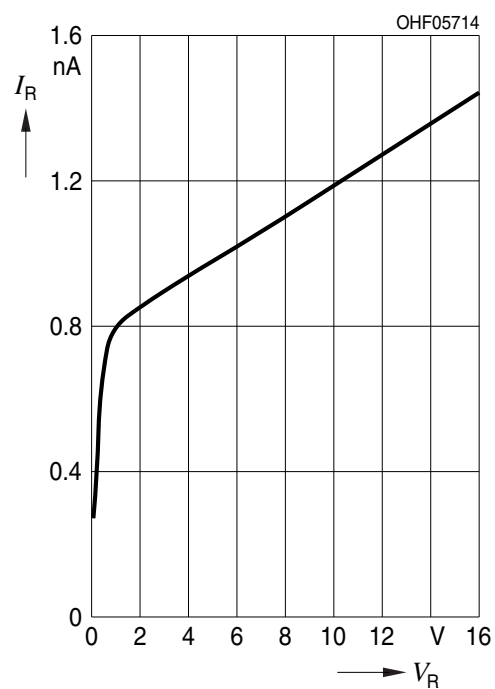

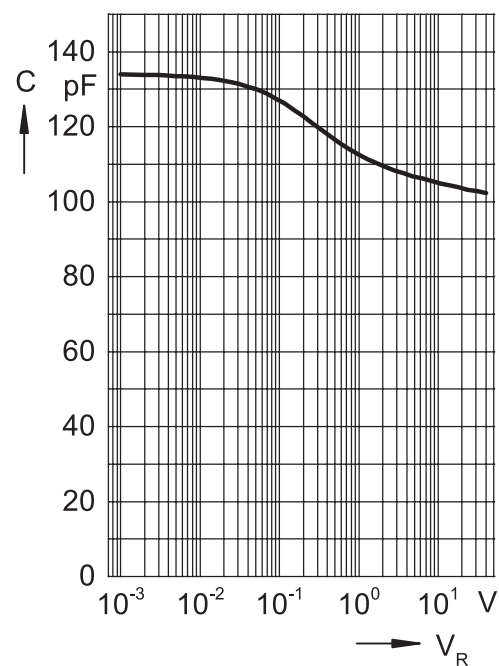

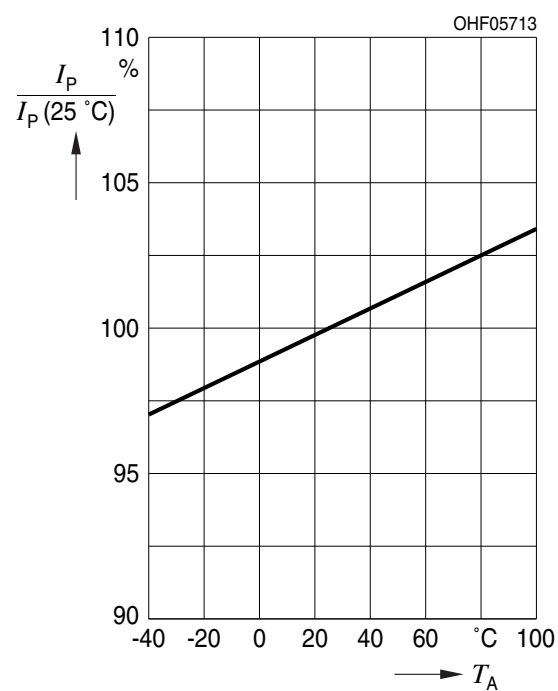

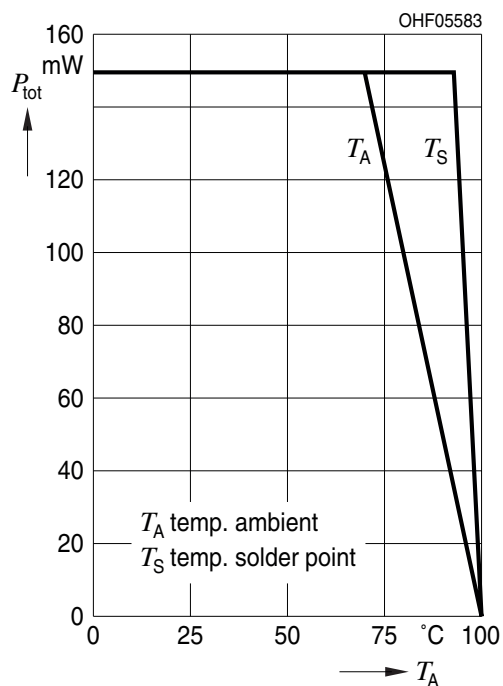

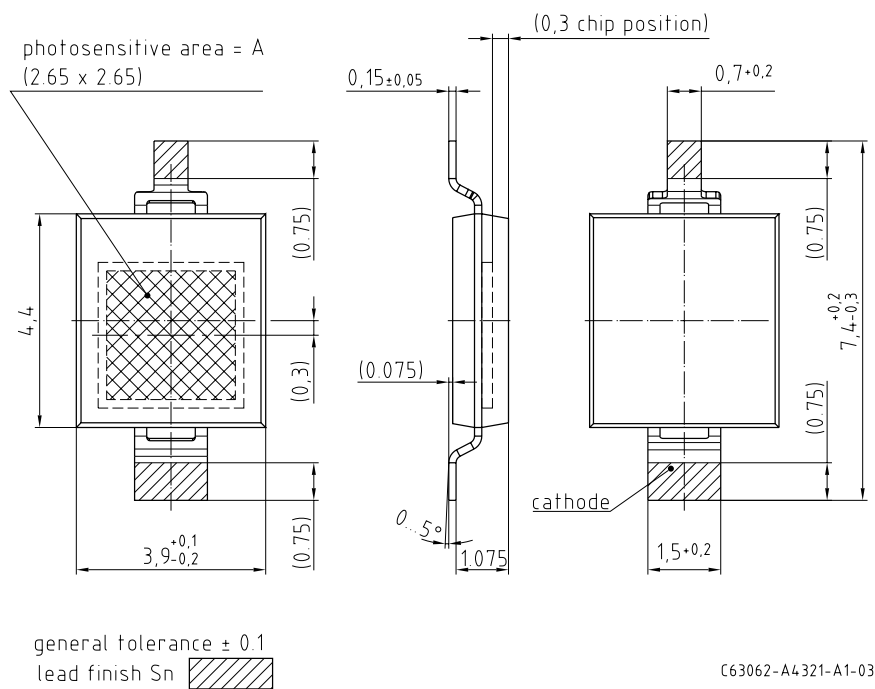


Power Consumption

Dimensional Drawing ³⁾

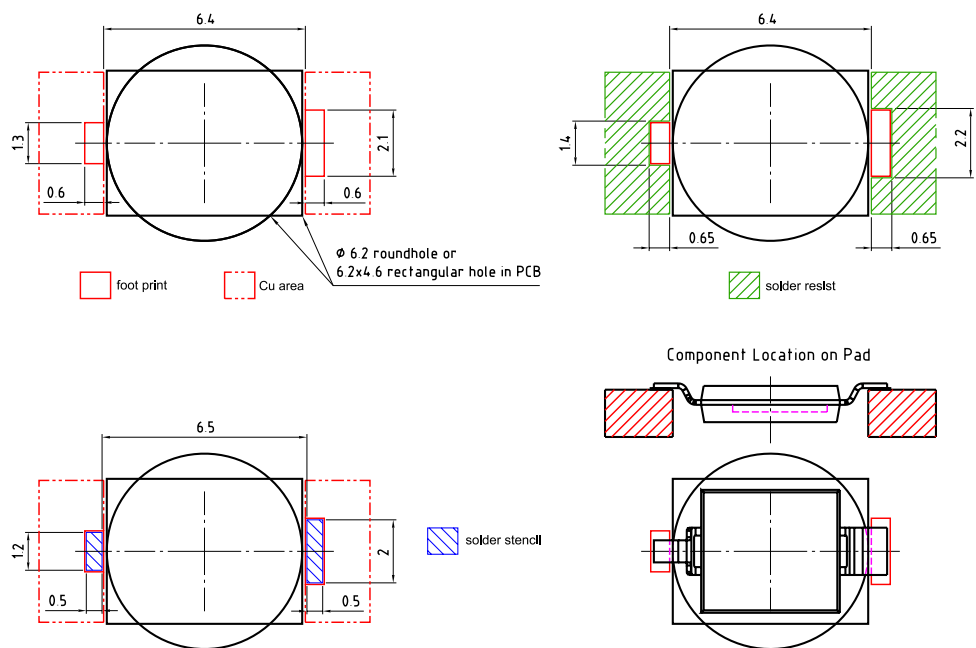

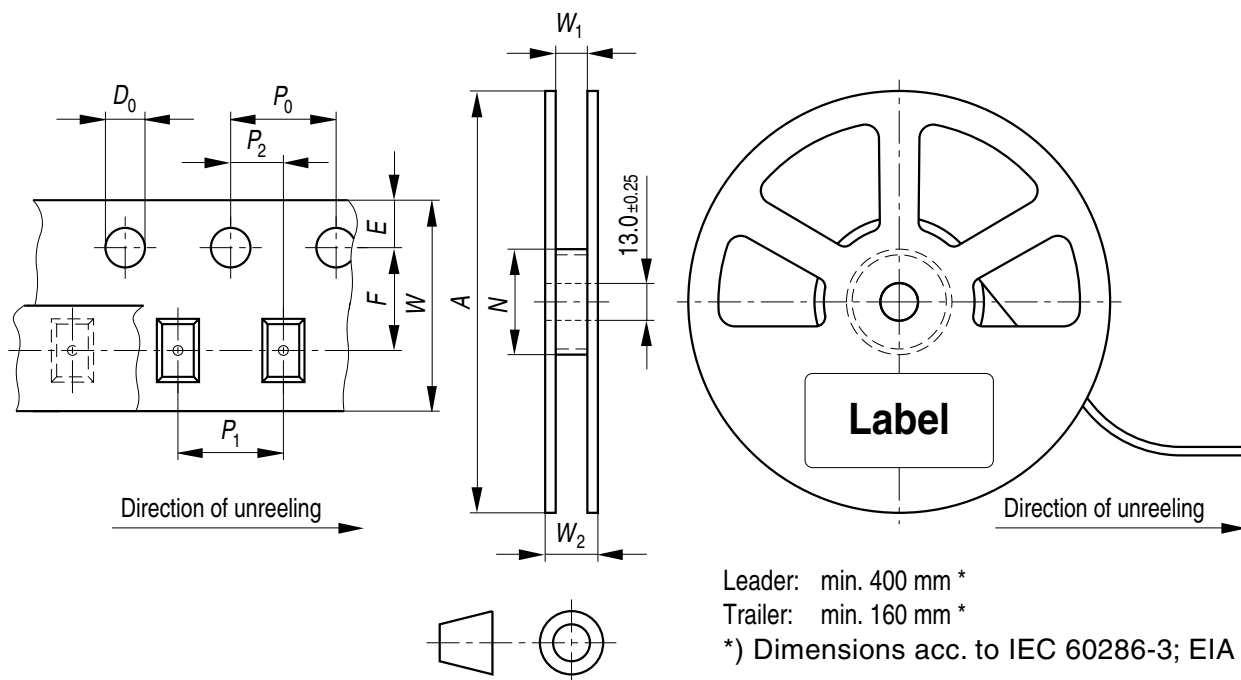

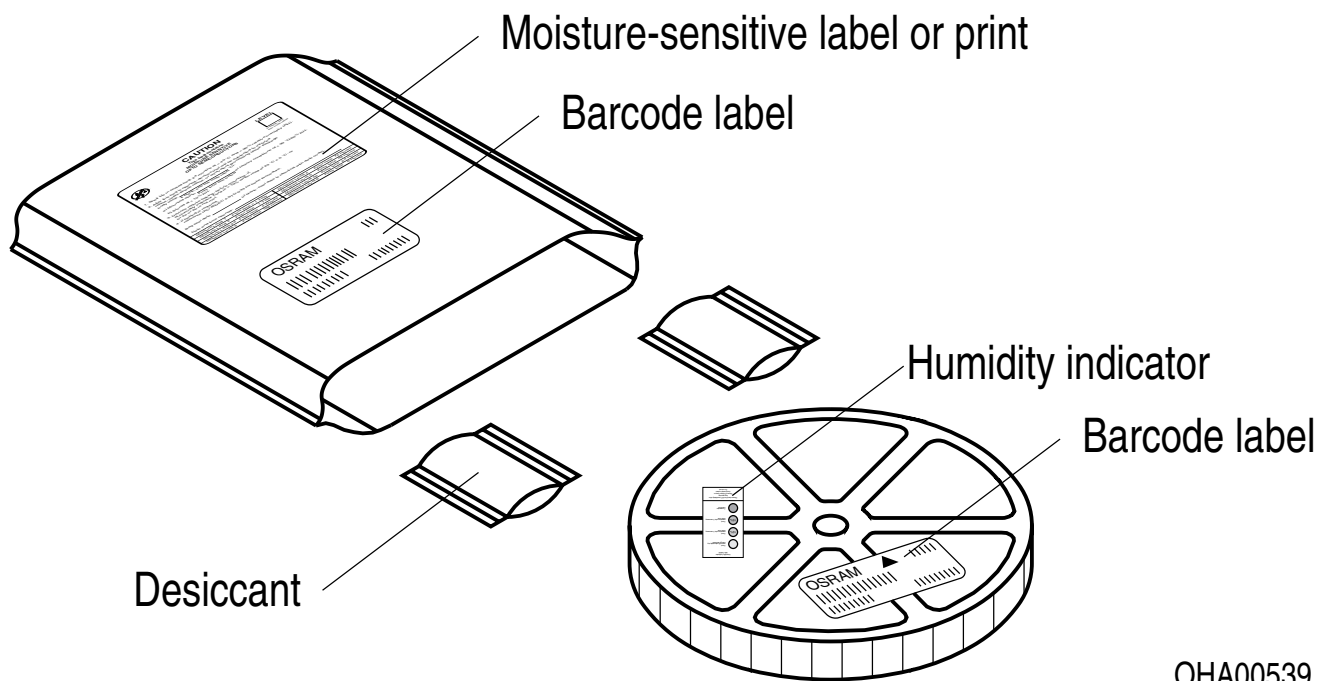

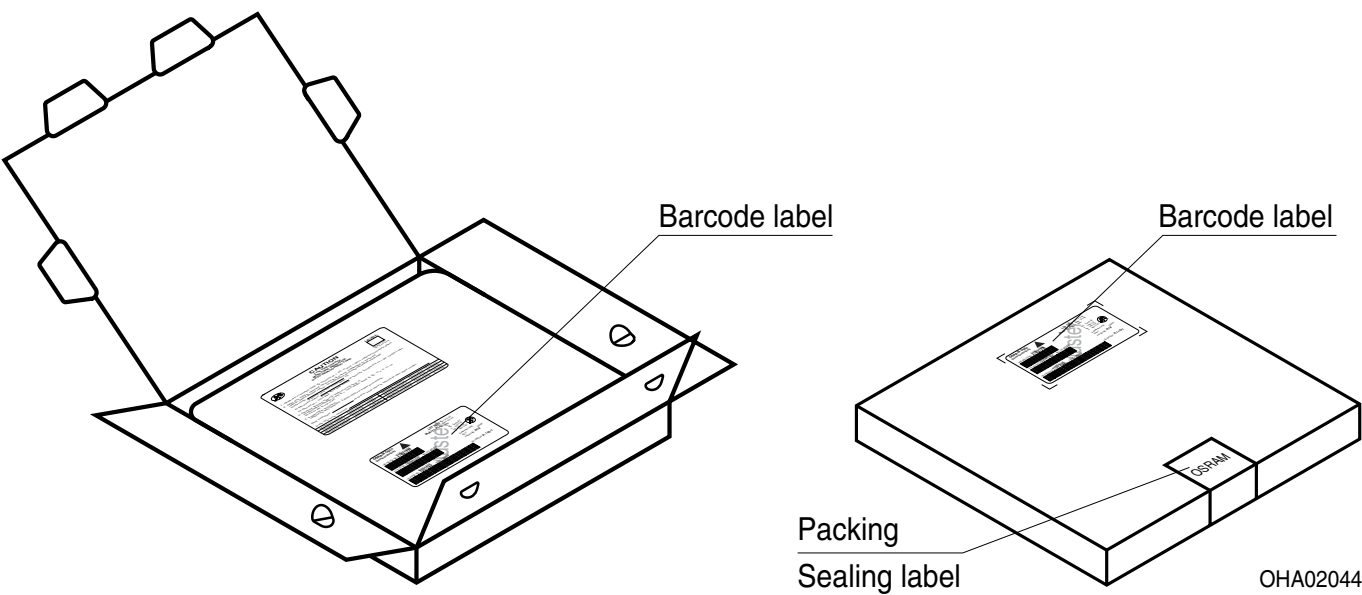

Notes
