


Relative Spectral Emission⁷⁾










Permissible Pulse Handling Capability


Permissible Pulse Handling Capability





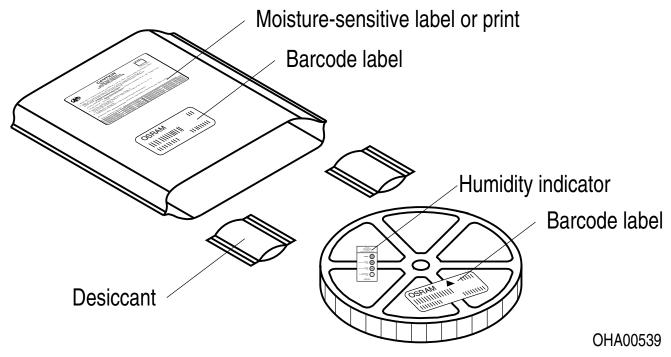
