




Relative Spectral Sensitivity ^{2), 3)}

 $S_{rel} = f(\lambda)$




Directional Characteristics ^{2), 3)}

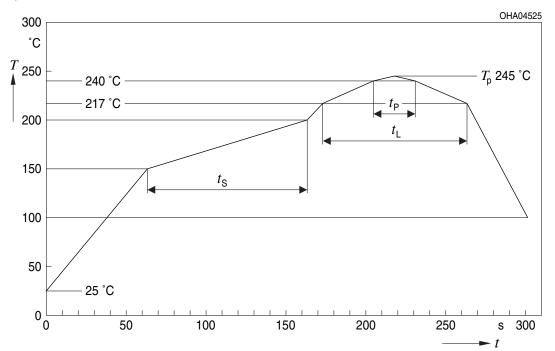


Bauteil positioniert Component location on pad OHFP2578




