## 1. Product profile

### 1.1 General description

Dual high-speed switching diode, encapsulated in a very small SOT323 (SC-70) Surface-Mounted Device (SMD) plastic package.

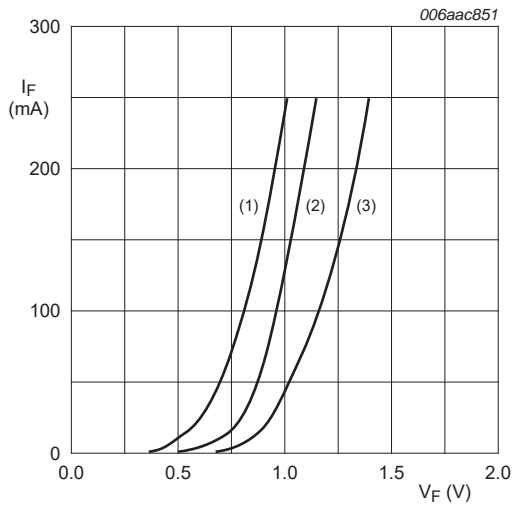

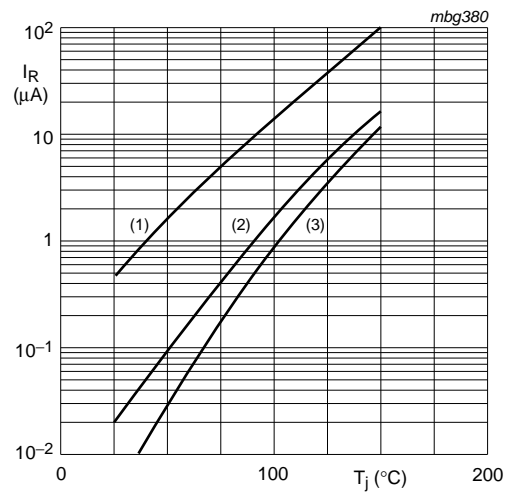

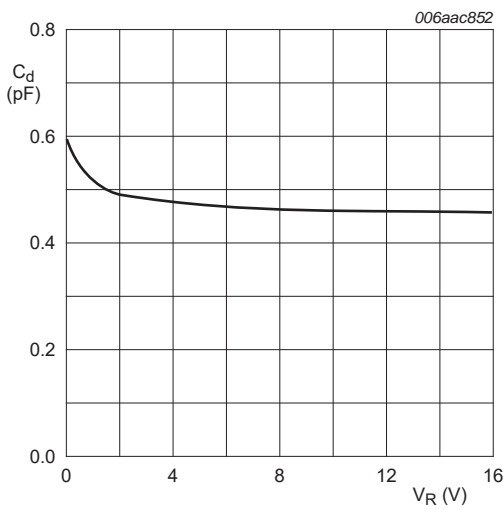

**Fig 1. Forward current as a function of forward voltage**



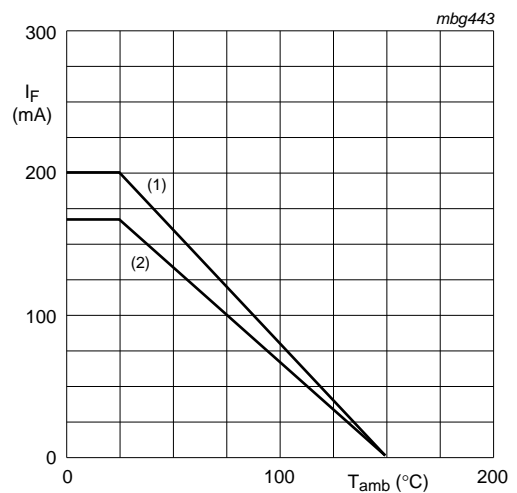
- (1)  $V_R = 80\text{ V}$ ; maximum values

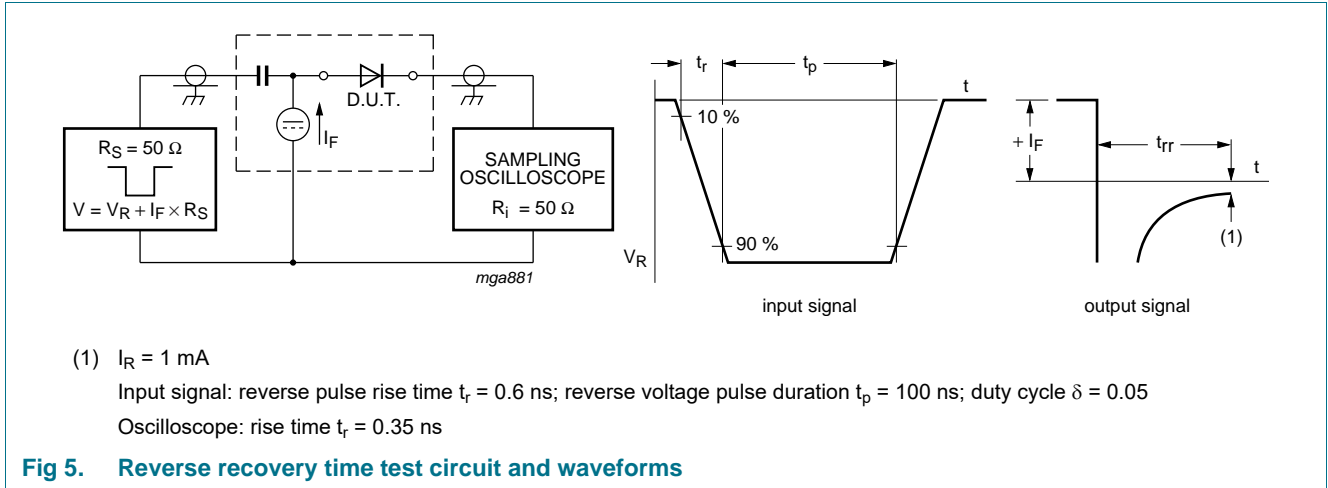


Fig 5. Reverse recovery time test circuit and waveforms

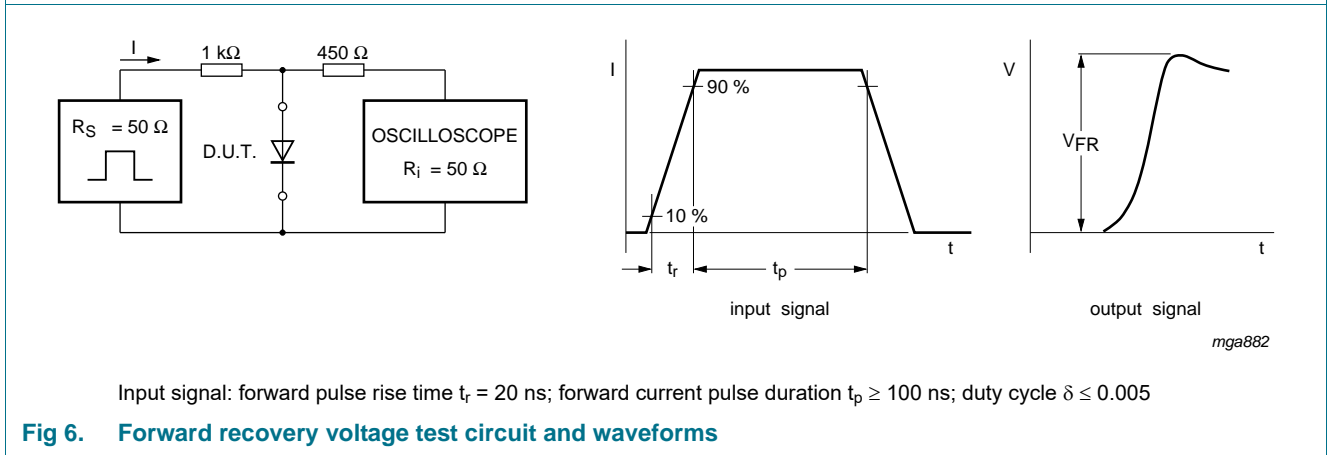
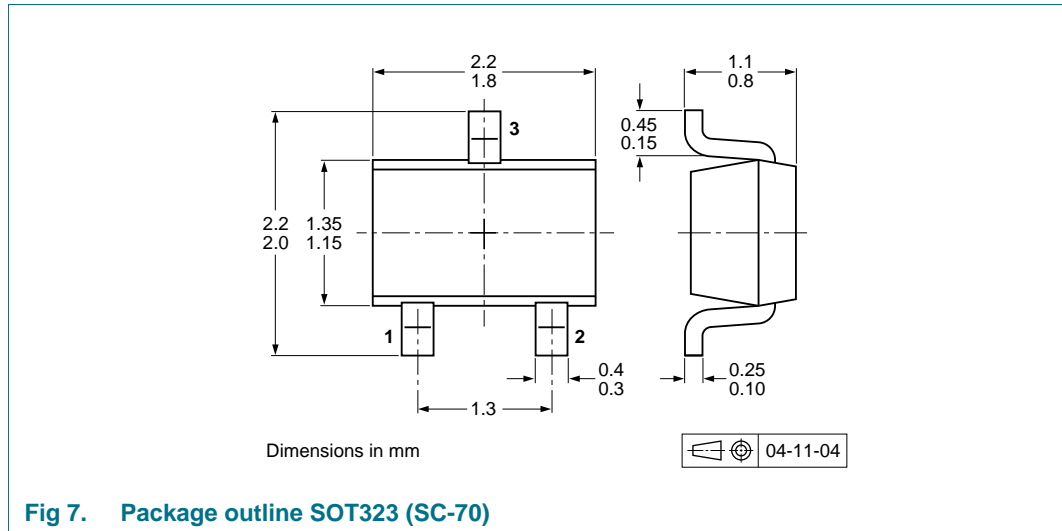


Fig 6. Forward recovery voltage test circuit and waveforms

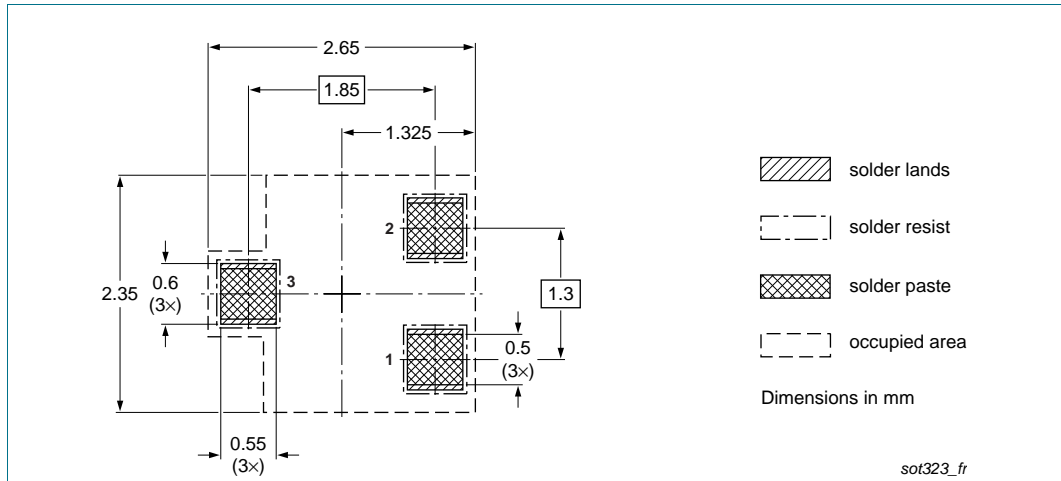


Fig 8. Reflow soldering footprint SOT323 (SC-70)

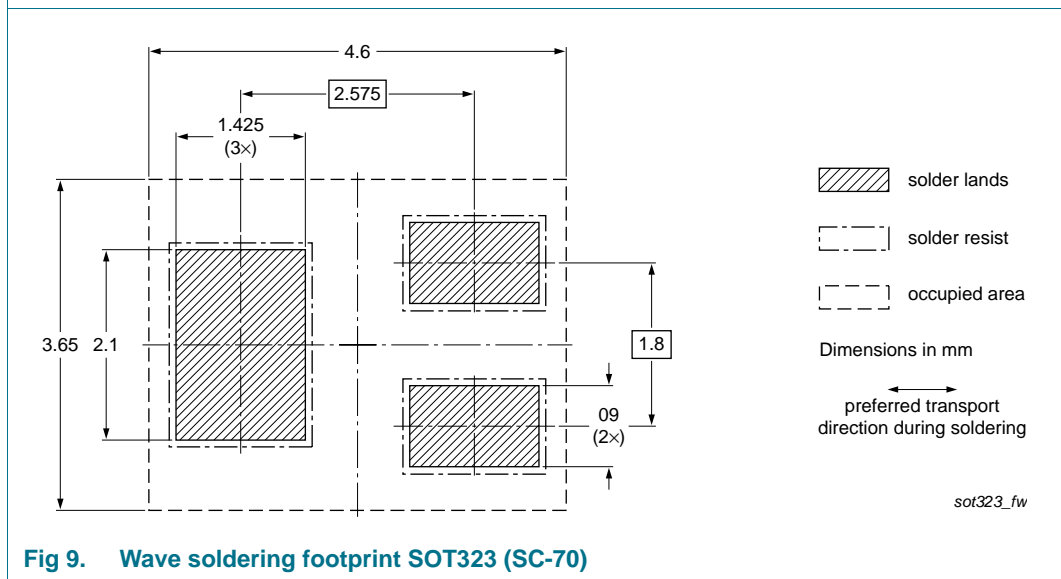


Fig 9. Wave soldering footprint SOT323 (SC-70)
